1. Make plans, which would cause the conditions described, as unacceptable to the policy EL-6, "Financial Condition and Activities."

- Addition A. Recap of budget appropriation transfers between governmental functions of all funds as required by NRS 354.598005.
- Addition B. Recap of full-time equivalent (FTE) transfers between governmental functions of all funds.
- Addition C. Recap of full-time equivalent (FTE) transfers between District Assignment Type code categories.
- Addition D. Running totals for each of the above transfers.
- Addition E. For each of the above transfers, a brief narrative detailing its alignment with the identified priorities described in item 2 of this policy and/or detailing the applicable waiver granted in item 2. d. of this policy.
- Addition F. A listing of any new position(s) or title(s) created since the last monthly recap, the Assignment Type code given to each, and a brief narrative description and justification of each new position, title and assignment type code.
