Bobby Jindal	Louisiana	Dead	declared in March 2011 state will not run a health exchange.

Rick Snyder	Michigan	Held	Wants a no-fed state exchange, but bill stuck in House.
Phil Bryant	Mississippi	None	Shelved until after November election.
Dave Heineman	Nebraska	None	Says state can wait to decide after November elections.
Brian Sandoval	Nevada	Active	Actively working to implement an exchange in 2012.
Chris Christie	New Jersey	Dead	Vetoed legislature's 2012 exchange bill.
Susana Martinez	New Mexico	Dead	Vetoed legislature's 2011 exchange bill.
Jack Dalrymple	North Dakota	Unclear	Law authorized exchange in principle, but no specifics passed.
John Kasich	Ohio	None	Gov. said he'd 'probably' let the feds run Ohio's exchange.
Mary Fallin	Oklahoma	Dead	Says state can wait to decide after November elections.
Tom Corbett	Pennsylvania	None	Bill stuck in legislature.
Nikki Haley	South Carolina	Dead	Gov, study commission recommended against.
Dennis Daugaard	South Dakota	Dead	"No point moving forward until after November elections."
Bill Haslam	Tennessee	None	"Study" continuing.
Rick Perry	Texas	None	"absolutely no interest in accelerating ... Obamacare."
Gary Herbert	Utah	None	No steps to make existing state exchange ACA-compliant.
Bob McDonnell	Virginia	None	Awaiting results of November election.
