In regards to your message to me on Facebook….let me briefly explain…..As I am sure you know, I filed a complaint with the Secretary of State— Election Division… and I am in the process of filing with the Ethics Commission. First I did not ask to be put on ANY district mailing list for the first three emails I mentioned above \$\preceq\$#8230; especially emails with you people pushing your political wishes….but I ABSOLUTELY did not in ANY WAY SHAPE OR FORM indicate my support of you for your re-election \$\pi\$#8230; or give you PERMISSION to share my email with anyone—especially outside of school. That was WAY out of line. You took information you had that was SCHOOL DISTRICT business and used it for YOUR campaign.
